
Earth Sciences (= "geoSTEM") are..." a range of applied and fundamental research fields, as well as related engineering disciplines and commercial undertakings. Together, they address the functioning of the Earth, the nexus of Earth and Human Systems, as well as the extraction and use of (abiotic) natural resources"



# Philosophy is the science to engineer your thinking.

About geoSTEM practices: ...no anthropogenic change would happen without geoscientists who are: finding coal, oil, and minerals, or forecasting weather for shipping commodities around the globe, estimating natural hazards for infrastructures, or stability of foundations of buildings, etc...

#### ...& Schemata



- ☐ The Human Niche is the planetary network of landscapes and seas profoundly shaped by engineering, production and consumption.
- ☐ Bundled by *global supply chains* people modulate the human niche.
- ☐ Geoscientists, the experts in geoSTEM, assist in operating the human niche.
- ☐ Geoethics explores societal contexts of the human niche through geoSTEM angles.



The latter is both a strength and a weakness because it is robust but limited.

# Socio-Historical Contexts of geoSTEM (1/2)

- ☐ The post-medieval European cultures
  - 1. engaged early with scientific studies of planet Earth;



- II. merged science, research, engineering, economy and applied ethics into a massive societal venture;
- shaped hegemonic practices at planetary scale;
- IV. mobilized gigantic physical, mental, and economic resources;

# and led to the Anthropocene, eventually.

# Socio-Historical Contexts of geoSTEM (2/2)

- Within the European cultural models, science evolved from an undertaking of a minuscule elite to a massive societal endeavour.
- □ Subsequently, the ethics of science gained relevance as deontology and societal feature.
- □ Explicit ethics in geoSTEM (geoethics) is a relatively recent field.

...specific ethics of the geosciences. What for ?

- Ethically sound geoSTEM implies to analyse jointly: (i) natural processes, (ii) socio-political drivers, and (iii) cultural features of the human niche.

## Recalling Design-Facets of Geoethics

- (1): Geoethics are of composite design (are a conglomerate)
  - {'earth sciences' + 'political/moral philosophies' } = geoethics



- > Therefore, the notion 'geoethics' is a plural.
- (2): Geoethics are a product of European cultural models.
  - > European philosophies shape geoethics.
    - > Therefore, geoethics are missing out other philosophies of humankind.
- (3): Geoethics are founded in [geo]scientific knowledge & comparative justice [\*]
- > [\*] "...[have] a strong awareness of the technical, environmental, economic, cultural and political limits existing in different socio-ecological contexts". http://www.Geoethics.Org/Definition
  - > Therefore, reliable geoethics need insights from the people sciences.

... Armatya Sen, an Indian Economist, Philosopher and Holder of the Nobel Prize, advocates 'comparative justice' [1] scrutinising Rawls theory of 'justice as fairness'. A. Sen works support that "choices taken in a specific social and cultural setting, that respect the ethical norms of this setting, may appear unethical elsewhere" [2, p.30]... That is what 'comparative justice' is about...

Google Scholar: between 2012 and 2022 about 800 references about 'comparative justice' but none relates it to 'geoethics'

#### Conclusions

- ✓ GeoSTEM disciplines are paramount for stewardship of the human niche.
- ✓ Geoethics offer specific ways of thinking within geoSTEM.
- Therefore, geoethics
  - (1) are about societal use of geoscience expertise;
  - (2) apply to societal dealings;
  - (3) require scrutiny from non-geoSTEM perspectives;
